Division Specifications

Short Stirrup Equitation: Open to riders 12 years and under. Jumps may not exceed 18" and trotting is allowed. Riders not allowed to cross enter into classes where they would jump over 18".

Short Stirrup Hunter: Open to riders 12 years and under on horses or ponies. No rider may show more than two mounts. Mounts may not cross enter into any other division except pleasure.

Leadline: Open to children 7 years and under. 50% rider equitation, 50% suitability of mount. Riders not allowed to cross enter into any classes where they would be asked to trot. Points go to the rider.

Pre-Short Stirrup: Open to riders 10 years and under. Riders may be asked to walk, trot, and perform simple equitation tasks. Riders not allowed to cross enter into classes where they would be asked to canter or jump.

Student Equitation: Open to riders in their first or second year of showing over fences at 2' or higher. Jumps to be a minimum of 2' and trotting is allowed. To be judged as an equitation division. Points go to the rider. Riders are limited to two years only, whether or not they compete over fences.

Pleasure Pony: Open to ponies ridden by juniors shown in hunter tack. To be judged on manners, suitability, soundness, and way of going.

Pony Equitation: Open to junior riders mounted on ponies. Fences: Small 2', Medium ponies 2'3", Large 2'6". At least 1/4 of the class to return for the flat phase.

Pony Hunter: Open to junior riders mounted on ponies. May be split small/medium and larges if entries warrant. Fences: Small 2', Medium 2'3", Large 2'6".

Equitation on the Flat: Open to juniors on horses or ponies, and adults on horses or ponies not entered in a pony division. To be shown w/t/c both ways and judged on position, control, and guidance. VHSA tests 1-19 may be used, excluding work over fences. May be split: Juniors (14 and under), Juniors (15-17), and adults, if entries warrant.

Pleasure Horse: Open to any horse shown in hunter tack. To be judged on manners, suitability, soundness, and way of going. May be split, junior and adult, if entries warrant.

Maiden Hunter: Open to horses or ponies in their first year of showing over fences at 2' or higher as of Dec. 1, 2018. May trot or canter fences. No restrictions on riders.

Green Hunter: Open to ponies in their first year of showing regulation heights ridden by juniors and horses in their first or second year of showing over fences at or above 2'6" as of Dec. 1, 2018. Fences: Small ponies 2', medium ponies 2'3", large ponies 2'6" and horses 2'6". May be split if entries warrant.

Limit Rider Hunter: Open to horses and ponies ridden by juniors and adult amateurs who are not entered in any classes jumping 2'6" or higher. These riders are not eligible for AA equitation, pony equitation, or children's equitation. Ponies must be ridden by juniors. Horses and ponies may cross enter into other divisions. Fences 2' or 2'3".

Low/Schooling Hunter: Open to horses and ponies. No restrictions on riders. Low Hunter jumps 2' or 2'3"; Schooling Hunter jumps 2'6" or 3'. May be split if entries warrant.

Children's/Adult Amateur Equitation: Open to juniors and adult amateurs on horses. Jump heights 2'6" or 3'. May be split if entries warrant.

Show Rules

Juniors: Riders who have not reached their 18th birthday as of December 1, 2018.

Ponies: To be ridden by **JUNIORS** in all classes except Student Equitation, Equitation on the Flat, Maiden Hunter, Low Hunter, Schooling Hunter, and Adult Amateur Hunter.

Hunter Classes: Judged on performance, manners, way of going and soundness.

Equitation Classes: Judged on hands, seat, guidance and control.

Six ribbons will be awarded in each class. Champion and Reserve ribbons will be awarded in each division. Points will be awarded according to the VHSA/BHSA rules.

Directions:

From Fredericksburg: Take 95 South to exit 110 (or Rt. 1 South). Take a right onto Ladysmith Road. Go about 7 miles until a fork in the road. Take a left onto Anderson Mill Road. Go one mile and take a right onto Chilesburg Road. Bellemont Stables is ½ mile on right hand side.

From Richmond: Take 95 North to exit 110 (or Rt. 1 North). Take a left onto Ladysmith Road. Go about 7 miles until a fork in the road. Take a left onto Anderson Mill Road. Go one mile and take a right onto Chilesburg Road. Bellemont Stables is ½ mile on right hand side.

1. ASTM/SEI certified helmets must be worn by **all riders** when mounted. Proper attire is required. Jackets may be excused by the judge.
2. Schooling and lunging horses is only allowed in designated areas.
3. Classes are \$14 each. California Warmup \$10. Fun Class \$8.
4. **A blank check must be left with the show secretary upon registering. A \$50.00 fee will be charged for all returned checks.**
5. Smoking is **not** allowed anywhere on the grounds.
6. Points will be awarded according to VHSA/BHSA regulations.
7. **A physical copy of a negative coggins are required within the last 12 months for all horses brought onto the grounds.**
8. No dogs or other animals allowed on premises.
9. The show committee reserves the right to refuse entries, cancel, combine and/or split classes or change officials if necessary.
10. Every class herein, which is covered by the rules and regulations of the current BHSA and VHSA rule book, will be conducted and judged accordingly. The judge's decision is always final.
11. All ages are as of December 1, 2018.
12. Schooling will be allowed in the ring the morning of the show and at designated times/places. The show management reserves the right to split or to terminate schooling.
13. **Bellemont Stables LLC, Bellemont Farm, employees and associates will not be held responsible for loss, accident, or injury during any show. Entry on the grounds constitutes agreement and knowledge thereof. All riders or guardians of underage riders are required to sign a release before riding.**
14. Parking and manure disposal allowed in **designated areas only.**
15. In the event of inclement weather, call: 804-448-2977 (farm), 757-636-5414 (Erin's cell).
16. Limited day stalls are available for \$30.00. Please call ahead to reserve. **Cancellations must be called in by 9 a.m. the Tuesday prior to the horse show; otherwise, you will be charged in full.**
